BACKGROUND

The financial and economic crisis hit Europe with full force at the end of the last decade. To fight this crisis is one of the biggest challenges of the European Union since its establishment. And although there can be seen signs of improvement in many areas like economic growth and financial stabilisation, some of the effects of the recession – above all the high unemployment – remain a big political and social problem in Europe.

Across the 28 EU member states over 26 million people or roughly 11% were classified as unemployed in December 2013. Especially youth unemployment increased in the last years. In September 2013, 19 EU member states experienced youth unemployment rates of more than 20% with five of these states exhibiting rates of more than 40%.

This situation has created fear and mistrust in the institutions and has led to the rise of Euro-sceptic groups and parties in the whole EU. With a view to the upcoming European elections on 25 May, the current development might end up in a weakening of the European Community and a loss of solidarity.

Greece is one of the countries within the EU which suffers most from the crisis. With about 26%, the unemployment in Greece is the highest in Europe and it is expected to increase even to 30% next year.

We cordially invite you to discuss the implications of unemployment for electoral choice with experts.
